**SECRETARY'S REPORT:** A motion was made by **Paul KB1MTW** seconded by **Roy KB1CYV** that the January Secretary's report be accepted as published in the Newsletter. The motion was approved.

OLD BUSINESS: Gary W1GRC reported that he has approached the owner of a tower in Whitman about moving the club repeater there and that he has agreed to the idea. Bill N1FRE suggested that the club draft a letter of thank you to send to the owner. It was discussed that the club would need to purchase a new high quality repeater antenna, and to allot money to pay a professional to install it. Bill N1FRE made a motion that \$1000.00 be allotted for these purposes. Paul KB1MTW seconded the motion and it was approved. Bill N1FRE reported that he presented Walter Dolson K1BZD with a certificate for being an Honorary Member of the club. Walter K1BZD is in a nursing home in Rockland and greatly appreciated being honored. Bruce NI1X also mailed Honorary Member certificates to Bob Schillinger KR6EC in California and Paul Swartz N1FWD in Florida. Ken KB1KVL and Joan KB1NAX have been working on designing certificates for the different club events, and for special EchoLink contacts. Paul KB1MTW reported that he is in the process of gathering the necessary materials to upgrade the electrical system in the clubhouse.

**NEW BUSINESS:** Bruce NI1X suggested having a possible kit building night for the club. Jim WG1L displayed several possible kits that we could consider building. One possible kit was a QRP transmitter built in a tuna fish can. #### PLYMOUTH NUCLEAR POWER PLANT

#### **EVACUATION DRILL PREPARATIONS by: The Bruce NI1X**

The City of Taunton, along with the Town of Bridgewater and the Town of Braintree, is one of the three "Host Communities" that are included in the Plymouth Nuclear Power Plant Evacuation Plan. This year there will be Federal Emergency Management Agency (FEMA) graded exercises for the Reception Center and Emergency Operations Center in Taunton in April. There will be several practice drills run in February and March and you may hear "THIS IS A DRILL" on the Taunton, Norwell and other local 2-Meter REPEATERS.

One part of "The Evacuation Plan" requires that there will be backup amateur radio communication between the Emergency Operations Centers in the Host Communities and the designated Reception Centers, the designated Transportation Staging Areas and the designated host schools.

It is interesting to note that over 20 Whitman club members are signed up and registered as volunteer amateur radio operators helping out at the local Emergency Operations Center (EOC) in Taunton, Bridgewater, Whitman, Carver, Pembroke, Plymouth, Brockton and Weymouth. These are dedicated volunteers who are able to actively support their local community's emergency preparedness efforts at this time. This article describes the Plymouth Evacuation Plan preparations from a City of Taunton perspective because Taunton is where I have been an active member of their Radio Amateur Civil Emergency Service (RACES) team since April of 2002. I expect to hear from the other Whitman Club members, participating in the other communities, for the March and April Whitman Club newsletter. Remember if I don't get a picture it did not happen.

#### PLYMOUTH NUCLEAR POWER PLANT - EVACUATION PLAN Cont:

If a serious emergency started to develop at the Plymouth nuclear power plant, the public living within a 10 mile radius of the plant will be alerted by **siren** to listen to radio advisories. As a precaution, if it happens during a school day, State officials could start moving students to host schools in Taunton, Bridgewater and Braintree and the Reception Centers in each of the three host communities would be made operational. As part of the plan, a core group of amateur radio volunteers (TEMA RACES Operators) would be activated and staffing ramped up as the Emergency Operations Center, the Reception Center and the Transportation Staging Area are made operational and as the host schools are cleared (local students sent home) to make room for Plymouth students. If a GENERAL EMERGENCY is declared, residents living within a 10 mile radius of the plant would be told to either shelter in place or evacuate to a safer location.

**John Viveiros**, a MEMA Region II staff trainer, reminded us that the important thing is that we have a plan in place and that we will have to work around all the unknown events like a vehicle accident that blocks a main highway or our equipment that decides to fail at the wrong time. **John** explained that as we improvise and work around these unexpected problems, it will probably take us a little longer to get the job done. I say - HAMs are use to that – it's called Murphy's Law.




#### HONORARY MEMBER CERTIFICATES






### WHITMAN AMATEUR RADIO PUBLIC SERVICE NET (WARPSN)


